DRIVERS FOR ACTIVITIES

Having recognized two major issues of global nature, ICENET was established in Japan to promote international cooperation at various levels, i.e. governments, businesses, private citizens, etc. The issues to be dealt with by ICENET are:

- Deteriorating global environment by inadequate systems that ignore the long-term impacts of human activities.
- Continuing regional conflicts being fought in 35 to 40 separate wars. At least 70 additional conflicts may escalate into major wars in the world.

Japan has become the second economy and the biggest ODA donor in the world. However, articulate voice for the world public is rarely heard from the Japanese politicians or government sectors. We believe that Japanese should actively participate in problem solving thus increasing the levels of international cooperation as the safeguard for the world security and common future for the benefit of all life.

THEORY BASE:

Multi-Track Diplomacy

Governments have often seemed limited in their ability to secure peace and stability. For this, many different groups are motivated to make a creative response. When all the approaches are considered as a system, each part is validated as having a contribution to make the whole with enhanced interrelationships between the parts so that the collective vision can be ultimately realized.
